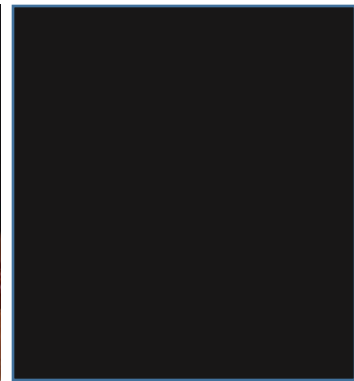


K&S RECOGNISED AS A LEADING FIRM BY LEGAL 500

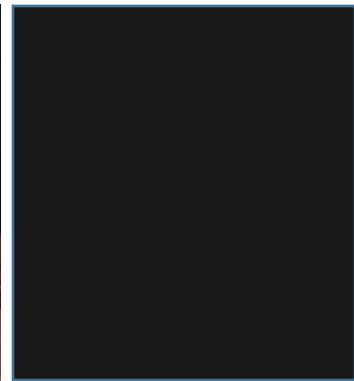
